DISCUSSION ITEMS

1. Committee Chair, Mrs. Liz Thompson opened the meeting at 6:42 PM and asked the Troop Officers to offer their reports.
2. Treasurer's Report – Mr. Henderson was unable to attend as he was preparing meat stick deliveries for the Troop.
3. Secretary – Mrs. Grosse reminded parents of the service project on **February 21st** from 5:30-8:30 at Britain's Farm Chuckwagon located at 4330 West Riverside Drive. Scouts are to arrive by 5:15 in the Class A uniforms. They will seat guests/keep areas clean in return for a donation to the Troop.
4. Fund Raising Chair – Mr. Henderson was unable to attend as he was preparing meat stick deliveries for the Troop. The meat stick fundraiser is going extremely well. Mr. Henderson is working to request donations in support of MATO supplies. MATO prep will be **February 29th** to mix the dry ingredients.
5. Scoutmaster – Mr. Thompson shared Reuban Herrera is ready to present his Eagle Project to the Parent Committee for consideration and there are 7 Scouts ready for their Board of Review.
6. Good of the Order – Mrs. Claridge shared there will be a Yuma Area Leadership Recognition Dinner next Thursday at 6:30. Mr. Thompson will send details.
